Re: Sustainable Growth Rate (SGR) Repeal and Payment Reform

Dear Chairman Baucus, Chairman Camp, and Chairman Upton:

As organizations representing health care providers, consumers, businesses, workers, vulnerable populations, the faith community and health plans, we urge bipartisan action this year to permanently repeal the SGR and transition Medicare reimbursement toward a value-based system.

Since the SGR's enactment, its ill-conceived approach to containing physician costs has repeatedly threatened to disrupt access to care. Today, there is a growing consensus that the seniors and disabled Americans who depend on Medicare should not have to face this threat again. But as it considers repeal of the SGR, Congress should use the opportunity to address the underlying problems in our health system.

Whether in Medicare or in the private market, health care costs continue to rise amidst serious and persistent problems in health care quality and access. To meet these challenges, we must strengthen our capacity to improve health care even as we spend our health care dollars more wisely.

Fortunately, that capacity is within our reach. The best health plans, the most promising federal demonstration projects and most innovative health systems have shown us a better way forward. When patients get the right care at the right time, when care is well-coordinated, and when physicians and other providers have the time to educate and engage their patients, we know that the best of American medicine actually becomes affordable. Yet this progress will remain the exception, not the rule, as long as today's volume-based reimbursement remains dominant. Because of its unique role as the largest payer for health care, Medicare has a special responsibility to lead the transition to delivery and payment approaches focused on value, including but not limited to value- and quality-based payment, patient-centered medical homes and accountable care.

In the coming weeks, each of our organizations stands ready to work with you. Together, we can make 2013 the year we put the SGR behind us and move America's health care toward a future we can all afford.
